- 8/10/22: Highgate, VT 78. Single vehicle ran off road and rolled over. Driver ejected and fatally injured. No seatbelt used.
- 8/12/22: Addison, Town Line Rd. Single vehicle lost control, rolled and single driver was ejected. Driver fatality. No seatbelt used.
- 8/15/22: Sheldon, VT 105. Two vehicle, head on crash. Driver fatality. Seatbelt used.
- 8/16/22: Brookfield, I-89 SB. Single vehicle rollover crash. Passenger ejected and fatally injured. No seatbelt used. Drugs suspected.
