- 8/4/21: Swanton, VT 105. Two vehicle crash with a motorcycle and farm truck. Motorcyclist fatality. Helmet used. Speed suspected.
- 8/5/21: Marshfield, Lower Depot Rd. Single vehicle ran off road and rolled over. Driver fatality. No seatbelts worn.
- 8/6/21: North Troy, VT 105. Pedestrian hit and run. No details at this time.
- 8/7/21: Manchester, US 7. Single vehicle crash, motorcycle driver fatality. Helmet used.
- 8/9/21: Stockbridge, VT 107. Two vehicle head on crash. Driver fatality. Seatbelt not worn.
- 8/9/21: Swanton, Memorial Way. Single vehicle ran off road into building. Driver and passenger fatalities. Unknown other details at this time.
