Contractor RFP Update

Project Updates

- Crash
 - Assisted with crash class at the Vermont Police Academy
 - o Attended the Traffic Records Forum in Milwaukee, WI
 - Testing the new Diagram Tool in Web Crash. I am unable to test it, but we are also adding Rhode Island to the Message Switch with the updates. Next steps are updating the crash form.

SIREN

- Attended the EMS Annual Conference.
- Beginning to draft year-end reports for 2018 data briefs.
- Continuing to onboard First Response agencies into SIREN
- Multiple meetings with VDH IT working towards an external-facing data dashboard using Microsoft PowerBI.
- NGA Learning Lab on Traffic Safety
 - Continue to meet on a monthly basis with cohort from NGA Learning Lab both by phone and in-person.
 - Team created a "white paper"/infographic and an electronic survey that was emailed
 to stakeholders to do an inventory of existing databases or data sources that can
 contribute to our traffic safety efforts.
- Created a weekly surveillance report in SIREN to look at MVC's relating to ETOH and/or drug-use. Next step is to compare against historical EMS data to analyze if there are any trends.
- Presented two topics at the annual VT EMS Conference, including documentation best practices and importance of accurate and timely EMS documentation.
- Hiring 6 new positions, 2 have left.
- DPS E-Citation Implementation
 - Understand that they need funding options going forward.
 - Ask legislature for funding source OR
 - Ask police departments to come up with money for the program
 - Deputy Commissioner Herrick has been advocating to go to legislature for the funding

- The budget meeting is next week with the commission with budget & finance
- Judicial Bureau plans to roll out a new ticket statewide when they go live with the case management system. It's not clear when this will happen yet. Judicial to provide a copy of ticket to DPS.
- Jim Paper distribution for e-ticket changed terminology through contract so this will not be a problem going forward.
- Department of Liquor Control DUI Data Integration
 - Scope of work is done.
 - Will be meeting with Amanda Bolduc to get started on this project soon.
- Model Inventory Collection (Intersection)
 - Received the first batch of intersection data from the consultant on Sept 30th.
 - Hope to start integrating into Safety Analyst.
- Future TRCC Meetings
 - With Vtrans slowly moving out of National Life, we would like to explore other options for locations of these meetings.
 - Suggestion to use the Dill Building near the airport.
- Special Topic: Traffic Records Forum, Milwaukee, WI
 - Jim did a presentation on the forum and the crash test we went to while there.
